# HISTORY: 30-Year Anniversary of the Dissolution of Czechoslovakia

On January 1, 1993, Czechoslovakia split into two independent states, the Czech Republic and Slovakia, in what is now known as the "Velvet divorce". (a reference to the bloodless Velvet Revolution of 1989, which had led to the end of the rule of the Communist Party of Czechoslovakia.)

The dissolution of Czechoslovakia took effect on December 31, 1992, and was the self-

determined split of the federal republic of Czechoslovakia into the independent countries of the Czech Republic and Slovakia. Both mirrored the Czech Socialist Republic and the Slovak Socialist Republic, which had been created in 1969 as the constituent states of the Czechoslovak Socialist Republic until the end of 1989.

Slovakia@30 is a collaborative project of the Slovak American Society of Washington, D.C. (SASW), Friends of Slovakia (FOS), and the Embassy of the Slovak Republic in Washington, D.C., to commemorate the <u>30th anniversary of Slovak independence</u>.

At the time of the peaceful split of Czechoslovakia on January 1, 1993, Slovakia was little more than three years into its post-communist transition. Many people create blogs or personal websites to connect with their ancestors, or create multiple family trees on Ancestry.com, FamilySearch.org, or MyHeritage, but have you put your tree on WikiTree yet?

WikiTree is for genealogy collaboration. This happens at two levels.

At the modern level, the collaboration can be <u>private</u>. Use WikiTree to collect and organize your personal family history and privately collaborate with family members. If you <u>invite</u> non-genealogist family members they might not move beyond this level.

Collaboration on deeper ancestry is between genealogists who are committed to accuracy and understand the importance of sources. To keep it enjoyable and productive, we trust each other to abide by a <u>Wiki Genealogy Honor</u> Code.

It is similar to FamilySearch.org, where the goal is to have only 1 tree. Here is an example of a friend's (distant DNA match) tree:





There are many manuscripts in the US, but not sure about Slovakia or Czech Republics? I thought the Library of Congress had only United States documents, but I was wrong, there is a European Reading Room section. These may be useful for those interested in **history**, but I don't think I can find my farmer ancestor's records here.

# The Czech and Slovak Collections at the Library of Congress



#### **General Collections**

The Library of Congress is considered to be the best repository of Czech and Slovak books, periodicals, and other reading materials outside the Czech Republic and Slovakia. The monographs and bound periodicals relating to the culture of the Czechs and Slovaks amount to some 115,000 items, with the yearly acquisitions of monographs averaging about 1,500 over the last 10 years. The Library has about 2,000 Czech and Slovak periodicals, of which about 600 are currently received, and more than 170 Czech and Slovak newspapers, with 14 titles currently received. It is estimated that about 80 percent of all these materials are in Czech or Slovak, English being the predominant language of the rest.

While the Czech and Slovak collections in the Library are generally good, they are especially strong for books and periodicals published after 1945. This is due to the fact that after 1945 monographs and periodicals published in Czechoslovakia (now the Czech and Slovak republics) were purchased by the Library on the basis of a blanket order.

The period of the 1920s and 1930s (the era of the First Czechoslovak Republic) is also well represented. Some of the holdings of works from this period have been acquired retrospectively, with stress being laid on volumes showing the excellent Czechoslovak craftsmanship in book design and printing.

# DNA COLUMN: NEW DNA TOOL - DNA PAINTER COVERAGE ESTIMATOR

**What is it?** The coverage estimator is a new tool at DNA Painter that lets you build a tree or import a GEDCOM and then mark the people in that tree who have tested. It then estimates the DNA coverage for the root person based on the testers.

Why would I use it? Looking at coverage for ancestors based on their descendants is inherently interesting. More specifically: if you're working on the DNA of a particular ancestor, the tool can help you figure out the best person to test next.

What do I need in order to do this? You just need an ancestor with some tested descendants.

More than four years ago, a genealogist called Paul Woodbury contacted me (Jonny) to discuss an idea. Paul had written an <u>interesting blog post</u> about DNA coverage. He was keen for there to be an interactive tool to help genealogists identify the testers who could add the most DNA coverage for the ancestor of interest.

I've now finally built the <u>coverage estimator</u> tool in collaboration with Paul and Leah Larkin. Leah has written <u>a comprehensive blog post</u> explaining the mathematics alongside possible applications. Here I'll explain in practical terms how to use it. If you've seen the <u>What are the Odds</u> (<u>WATO</u>) tool, you may find the interface familiar. It's a slimmed down version of the same tree structure, but with a different color scheme.

# Possible uses for DNA coverage estimates

Here are some potential applications for this tool:

- Helping to select the tester who will boost the DNA coverage of a specific ancestor as much as possible
- Providing a guideline for expectations when embarking on an ancestor reconstruction project (e.g., using Gedmatch's Lazarus tool or Borland Genetics)
- ... and my main activity with the tool so far: randomly choosing an
  ancestor in your tree, adding in known descendant testers, and
  viewing the approximate coverage out of pure curiosity!

# Marking testers

Once you have your tree, it's time to indicate which of your ancestor's descendants has tested. To do this:

- Hover over the relevant person and click Mark as tested
- If you hover over someone you've already marked, you will see the option Mark as not tested

Those in the tree who you've marked as tested will have a black background. If you mark the child of someone who has tested as a tester, they will still be marked, but this will not change the overall coverage estimate.

#### How to use the coverage tool

#### Before you start you'll need:

- · A person in your tree you're interested in estimating coverage for
- An understanding of which of this person's descendants have tested and where they fit into the person's tree

#### How to use:

Set up your tree

#### Import a GEDCOM (what's this?)


- · Click the 'Load' button on the right and then click 'Import GEDCOM'
- Drag your GEDCOM file onto the dashed 'Drop a GEDCOM file here' box, or click on that box to browse your computer for the file
- · Then type the first few letters of the name of the person you want to import
- A list of matching names will appear with birth/death years; click on the name of the person you want to import


#### Or build manually

- Click on 'Enter coverage subject name here' and enter your ancestor's name.
   Then use 'add child' to add descendants
- To indicate that someone is deceased and unable to test, hover them in the tree, click Add/Edit Details and enter a death year
- 2 Indicate which descendants have tested:
  - Hover over anyone who has tested and click Mark as tested.
  - Their node will then turn dark and will count towards the overall coverage calculation
- An estimated value for the amount of the root person's DNA that is covered by tested descendants will appear at the top left.

The percentages generated by this tool are **estimates** based on typical inheritance patterns.

would bring estimated coverage up to ~50%, an increase of 25%

Once you've marked all known testers, the percentage displayed at the top left will represent an estimate of the total coverage of this ancestor that these DNA testers represent.

For more background on the calculations, please see <u>Leah's blog post</u>.

To clarify, the coverage percentages you see in this tool are <u>estimates!</u> Beyond the 50% that a child inherits from his or her parent, all coverage percentages are estimates. For example, I have a niece who inherited 33% of her DNA from her maternal grandmother as opposed to the 25% that we might expect. However, these estimates remain interesting and are helpful when considering the possible impact of new testers.
