### **New Travel Screening Coming at End of 2026 for Europe:**

Why is the EU launching a new travel authorisation system?

Starting in Q4 2026, the European Commission will roll out a U.S. style electronic travel authorisation system for <u>visitors from countries</u> that are currently not part of the EU. These visitors have been granted visa-free access to the <u>EU and Schengen member countries</u> through virtue of their good track record on security issues and, thus, have not been deemed as a threat to EU security. However, the EU is wanting to strengthen its border security as well as digitally screen and track travelers entering and leaving EU countries.

ETIAS stands for the European Travel Information and Authorisation System. The system will check the security credentials and charge a fee to travelers visiting EU member countries for business, tourism, medical or transit purposes. Travelers who currently visit Europe visa-free are able to enter EU and Schengen Member countries cost-free and without any digital security screening prior to their arrival to Europe. ETIAS is not a visa, and is more accurately referred to as a visa-waiver. The ETIAS, like the ESTA, is a travel authorisation for travelers not requiring a visa to visit Europe. Under the ETIAS, these visitors will undergo additional security checks prior to being permitted to enter the EU. The ETIAS will be mandatory for citizens of such countries as the United States, Australia, New Zealand and Canada. Learn more about the various aspects and implications of ETIAS by visiting the FAQ.

Barring any delay in implementation, the ETIAS is due to come into effect in Q4 2026. After the initial launch, there may be a short-period of 3-6 months where ETIAS may not be mandatory for travel. This is to allow the EU to work through any system issues which may negatively impact travellers due to complications with the initial roll-out.



### **VA Database BIRLS Database**

The BIRLS old version on Ancestry only goes up to 2010 with deceased veterans who had an open case. But, these BIRL files have C-files that are different than the USCIS C-files. And **you** can make a Freedom of Information Act FOIA request to ask for records. Note: Beware YOUR FOIA request will be put into the VETERAN's XC-File

### **About the Speaker:**

Brooke Schreier Ganz is the founder and president of the non-profit organization Reclaim The Records, which obtains and freely publishes genealogical and historical materials held by local, state, and federal government archives, agencies, and libraries. She was the first genealogist to successfully sue a government archive under a state Freedom of Information law for the return of historical materials to the public domain.

Ever wanted to know more about the veterans in your family, and found those "military records were lost in a big fire in 1973",etc? The BIRLS records are a "different" set of military-


related historical records that were basically unknown to most researchers, but which you can now order right from your home, using just your web browser, for any deceased US veteran, related or not -- and for free!

They showed the kinds of unique genealogical and historical data that has been just sitting in these files for years, with examples of files they've received from the VA. Once you FIND a name, then you can ask for a C-FILE (or XCfile after death), the "REAL" file. Like the Civil War, Revolutionary War & War of 1812 Pension file, not helpful for most of our members, but also have WWI, WWII and Korean War for later ancestors' records. A lot of 20th century military records don't exist because of the big fire in 1973. It has location where enlisted, may have DD214 Discharge record and possibly names of people he/she served with. It may even have the places of birth of parents, or it may have medical reasons if discharged, psychiatric records etc.

It took a Freedom of Information Act (FOIA) request, two FOIA Appeals, and a federal court case filed in the Southern District of New York to reclaim this data for the public, and then several more years for the VA to clean up and turn over the data. \*From website \* RECLAIM THE RECORDS: a non-profit organization of genealogists, historians, journalists, teachers, and open data enthusiasts.

### Would you like a copy of the full Claims File (C-File) for your relative?

You can request and receive photocopies of a deceased veteran's full Claims File (C-File) through the Freedom of Information Act (FOIA). Each C-File will contain **many more details about the veteran's life and service**, with sometimes a hundred pages or more of additional information, including biographical details, service records, educational ("GI Bill") or home loan benefits, pension or life insurance, and many other types of historical information related to a veteran's service.

Anyone can file a FOIA request for a deceased person's file. You do not need to be a US citizen or resident, and you do not need to be a relative. You do need to provide your name and contact information, including your e-mail and mailing address. You can make a FOIA for your veteran's file right from this website! They built a special online template to help us, then the link faxes the information right to the VA's special FOIA processing center for C-Files, for free!

The VA might ask you to pay a few cents per page for any file that they find and copy, but they've found that they usually don't bother to charge FOIA requesters for this service. Occasionally, small parts of the file may be redacted (blacked out) if any part of the information in it refers to a possibly-living person, or for other legal reasons. Processing times for these types of FOIA requests usually take a few months, and the documents will most likely be sent to you as digital files placed on a DVD sent by postal mail.



Step 2: You do need to put in your info. & Steps 3 & 4, agree to the terms & sign. They will send you the file information in the mail on a DVD.

This gets sent to the VA Fax line.

It takes 6-8 weeks to receive a letter in the mail saying that they received your FOIA request Then, it will take about 4 months (maybe longer since they have sent 15,000 FOIA requests to them) to receive the XC-file, or letter saying that they didn't have it. The DVD has a .pdf file on it.

### What to do if you can't find a veteran's name in the BIRLS database

The BIRLS database is not a comprehensive database of all American veterans, but rather a partial and incomplete index of veterans who were eligible for VA benefits or whose heirs had some kind of contact with the VA regarding benefits. Furthermore, the version of the BIRLS database on this website only includes the names of people who were known to the VA to have been deceased at the time when Reclaim The Records won their FOIA lawsuit in 2020, with the subset of the database being exported and turned over in mid-2022. That being said, almost all veterans who served in the late nineteenth or twentieth centuries probably do (or did) have some sort of claims file stored with the VA, likely in one (or more) of their warehouses, and that file may

We reviewed our records and found no holdings, but you can appeal within 90 days of receiving this letter. (this process is on their website)

They may not be in the file if they didn't file any claims after 1970.

### Congratulations, you have successfully filed a FOIA request with the US Dept. of Veterans' Affairs!

We have faxed a copy of your FOIA form to the Veterans Benefits Administration's Centralized Support Division. We have also e-mailed you a copy for your records.

The agency is *supposed* to acknowledge the receipt of your FOIA request within <u>twenty</u> business days, and ideally by e-mail, but it will probably be more like two months and probably arrive via postal mail. Nevertheless, they should eventually send you a formal FOIA acknowledgement letter, followed a few months after that by a packet of information on the veteran you're researching.

If the VA does not provide you with any response after several months, or if they claim they cannot find the file at all, or if you believe the resulting files were not properly produced or had too many unnecessary redactions, then you can file a free FOIA appeal with the VA's Office of General Counsel at this email address: ogcfoiaappeals@va.gov.
